# CORPO-RATE PROFILE

The LDA aims at bringing drainage development to the doorstep of citizens. The LDA has been a major driving force in the development of drainage infrastructure across the island. Construction of major drainage infrastructure and construction of retaining walls near river and also training projects play a key role in our National Disaster Risk Reduction strategies. As per provision made under the LDA Act 17 section 7, the LDA shall be administered by a Land Drainage Board. The LDA has thus, set up the Land Drainage Board.

## CORPORATE GOVERNANCE REPORT

### Introduction

The Land Drainage Authority (LDA) is a body corporate established in January 2018 following the proclamation of the Land Drainage Authority Act in April 2017. The LDA operates under the aegis of the Ministry of National Infrastructure and Community Development (National Development Unit) and has been established with a view to increasing the resilience of Mauritius to flooding and better manage flood risks.

The objectives of setting up the Authority are to highlight the inter-dependency between environment, integrated land drainage management and land use planning in order to protect people and assets against flooding in Mauritius and Rodrigues. The LDA acts in a pro-active and collaborative way taking into consideration its contingency planning and approach towards risk preparedness.

### **Principle ONE - GOVERNANCE STRUCTURE**

### **Board Structure**

The LDA is administered by a Board known as the Land Drainage Board. It has the following main functions:

- (a)To approve, monitor, review and evaluate the implementation of strategies, policies and business plans; (b)To prepare a statement of corporate objectives;
- (c)To ensure that the LDA complies with the highest standards of the governance and that it has an effective system of control in place so that the risks can be properly assessed and managed; and (d)To ensure that communication of all material information to the stakeholders be made in a transparent way.

### **Vision**

To increase resilience of the Republic of Mauritius to flooding through an effective and efficient land drainage system.

### Mission


- Formulate and ensure the implementation of a Land Drainage Master Plan for Mauritius to address flood risk in a pro-active and holistic manner
- · Conduct and coordinate research and development on land drainage and watershed management
- Attenuate the impacts of flooding by continuously improving the land drainage system
- Ensure a well maintained land drainage system through sensitization and awareness raising campaigns

### **Organigram structure - Land Drainage Authority**

The LDA has an organisational chart which depicts the different existing staffing position and their respective major accountabilities with respect to the functions devolved on the Authority.



### **Objects of the Authority**

As per the LDA Act, the authority is responsible for:

- (a) the development and implementation of a land drainage master plan;
- (b) coordinating the construction of drainage infrastructure by the local authorities , the NDU, the RDA and any other relevant stakeholder; and
- (c) ensuring that there is a routine and periodic upgrading and maintenance of the drainage infrastructure.

### **Duties and Functions**

The duties and functions of the LDA are to:

- a) carry out an inventory and mapping of all the existing natural and manmade drainage infrastructure;
- b) undertake a study based on a hydro-meteorological and hydro graphic survey and produce and keep under review a flood risk map and a National Land Drainage Plan.
- c) conduct and coordinate research and development on land drainage and watershed management and share all available information with all relevant stakeholders;
- d) identify in collaboration with the local authorities, the NDU, the RDA, the NDRRMC and any other relevant stakeholder, flood risk areas;
- e) cause any works related to land drainage to be carried out by the relevant local authorities, the NDU, the RDA and any other relevant stakeholder;
- f) cause to be carried out the upgrading and maintenance of the drainage infrastructure by the local authorities, the NDU, the RDA and any other relevant stakeholder;
- g) prepareandimplementlanddrainageschemes;
- h) advisetheMinisterontheformulationandmanagementoflanddrainagepolicies and strategies;
- i) advise and update the Minister on any matter relating to land drainage; and
- j) take any other action deemed necessary in line with the provisions of this Act.8

### Principle TWO – THE STRUCTURE OF THE BOARD AND ITS SUB-COMMITTEES

The LDA is administered by the Land Drainage Board consisting of a Chairperson appointed by the Minister and of senior representatives of different Ministries and Institutions. The Land Drainage Board ensures that the principle of good corporate governance, as applicable in Mauritius, are fully adhered to and form an integral component in the manner the activities and projects of the Authority are conducted. The structure, composition and appointment of members are established as per the provisions of Section 7 (2) of the LDA Act 2017. The composition of the Board is as follows:

- b) Members :
- i) a representative of the Ministry of Environment, Solid Waste Management and Climate Change;

- iv) a representative of the Ministry of Local Government and Disaster Risk Management;



- v) a representative of the Ministry of National Infrastructure and Community Development (National Infrastructure Division);
- vi) a representative of the Ministry of Energy and Public Utilities;
- vii) a representative of the Water Resources Unit;
- viii) a representative of the Ministry of National Infrastructure and Community Development (National Development Unit);
- ix) a representative of the Road Development Authority;
- x) a representative of the National Disaster and Risk Reduction Management Centre;
- xi) a representative of the Police Department;
- xii) two Independent Members; and
- xiii) Ag. Secretary: Ministry of National Infrastructure and CommunityDevelopment (National Development Unit).

### Principle THREE-DIRECTOR APPOINTMENT PROCEDURES

The Board is appointed by the Minister responsible for the portfolio of the National Development Unit in line with Section 7 of the LDA Act. The Chairman is appointed by the Minister on such terms and conditions as the Minister may decide as per Section 7(2) of the LDA Act. Eleven of the Board Members are representatives of different Ministries and 3 persons, other than public officers or employees of a statutory corporation, having wide experience in the field of land drainage or administrative matters to be appointed by the Minister.

### a) Conflict of Interests

No person who has any interest in any civil engineering undertaking or consultancy shall be appointed as member. Any member who acquires an interest in any civil engineering undertaking or consultancy shall resign from the Board.

### Principle FOUR-DIRECTOR DUTIES, REMUNARATION AND PERFORMANCE

### Role, Function and Powers of the Board

The role, function and powers of the Board are determined by the LDA Act. The Board is the focal part of the Corporate Governance System and is ultimately accountable and responsible for the performance and affairs of the Authority. Its main responsibility is to determine the Authority's strategies and policies, performance-based budgeting; and compliance in accordance with relevant laws, regulations, codes of best business practices.

### **Directors' Responsibility for the Financial Statements**

The Authority's Director is responsible for the preparation and fair presentation of the financial statements in accordance with International Accounting Standards and in compliance with the requirements of prevailing statutes.

### **Remuneration of Board Members**

Every member shall be paid such allowance as the Minister may, with the approval of the Minister to whom responsibility for the subject of finance is assigned, determine.

Fees paid to the Chairperson, Members and Secretary of the LDB are as follows:

Chairperson	Rs 40,000 (monthly)
Members	Rs 2,500 (per sitting)
Secretary	Rs 2,500 (per sitting)

Members are also paid a travelling allowance of Rs 375 by car or Rs 60 by bus per sitting, where applicable.

### Principle FIVE-RISK GOVERNANCE AND INTERNAL CONTROL

The Land Drainage Board is responsible for the total process of risk management and ensures that the Organisation develops and executes a comprehensive and robust system of Risk management. The process of risk management includes the systematic and continuous identification and evaluation of risks as they pertain to the different units/ sections of the organisation. Strategies are then developed to eliminate, transfer or mitigate each risk as and when they are identified and evaluated.

### **Principle SIX- REPORTING WITH INTEGRITY**

### **Submission of Annual Report**

The Annual Report incorporating the Financial Statement of the LDA is prepared according to International Public Sector Accounting Standard (IPSAS) and submitted to the National Audit Office within the prescribed submission

date after duly approved by the Board. After the Annual Report is audited by the National Audit Office, the Land Drainage board submits it to the Minister who then, at the earliest opportunity, lay a copy of the Annual Report and audited accounts of the Authority on the table of the National Assembly. It is then posted on the website of the LDA and filed/tabled with all the relevant authorities as per statutory requirements.

Additionally, observations and recommendations made by National Audit Office are brought to the Board and actions taken to improve systems and processes. In this line following observation made in the previous Financial Statement for the year ended 30th June 2020 by the National Audit Office, the Financial Statement were amended and a new set of Accounts based on the IPSAS was submitted.

### **Integrated Sustainability Reporting**

LDA has developed and implemented social, safety, health and environmental policies and practices that in all material respects comply with existing legislative and regulatory frameworks.

### Anti-Corruption Policy

With a view to preventing fraud and corruption at the LDA and to ensuring Good Corporate Governance practices, the Board has put in place various control mechanisms. The Board shall not delegate its power to borrow money or raise loans.

No deed or other document shall be executed or signed by or on behalf of the Authority unless it is signed by the Chairperson or, in his absence, any other member designated by the Board and the Director or, in his absence, any other employee designated by the Board.

### • Environmental Issues

Sustainable development and environmental issues are taken into consideration in the design and implementation of project.

### Safety and Health

The LDA complies with the Occupational Safety & Health (OSH) Act and other regulations and legislations regarding safety and health issues. Policies and procedures have been established and updated in this respect for continual improvement. An OSH management system is implemented for systematically and periodically assess risks, devise and implement control measures to eliminate and minimize risks assuring for the safety & health of employees.

The Safetyand Health Officer conduct a monthly visit at the LDA to ensure that the Authority is complying with the OSH Act 2005. If ever, an anomaly is noted, the Safety and Health Officer calls for a meeting to raise the issue.

### Social issues

With a view to promote exchange of information, the LDA has provided training facilities to trainees from other institutions as a corporate social action. Additionally, it has enlisted a number of young graduatesunder 'Service to Mauritius' (STM) Programme and Trainee Engineers to provide them with skills, competence and opportunities for registration.

### Gender Policy

The Authority is committed to achieving gender justice as a matter of basic human right and fundamental principle. The Authority promotes an enabling environment where both men and women are equally respected and valued. Adopting and incorporating a gender approach in all developmental issues remain a prerequisite to attain full human development.

### Code of Ethics

The LDA is committed to the highest standards of integrity and ethical conduct in dealing with all its stakeholders and Staff at all levels. Three main codes of ethics followed in LDA are:

- -Integrity
- -Teamwork
- -Objectivity



### **Principle SEVEN-AUDIT**

### • Internal Control System

The Board is primarily responsible for the effectiveness and efficiency of the system of internal control, while the design, implementation and monitoring of the system devolves on management. Each unit in the Organization has its own internal control procedures and mechanism to ensure that operations are carried out accordingly and Internal Audit Unit is present to ascertain that rules and regulations are followed and adhered to. Any breach of internal control mechanism set up by management or any unethical/irregular reported to Management and ultimately to the Board.

### Accounting

The Board is responsible for the preparation of accounts which fairly presents the state of affairs of the Authority and the results of its operations and which had to be complied with International Accounting Standards. In this context, the Board is responsible for adequate accounting records, maintenance of an effective system of internal control, and choice of accounting policies supported by reasonable prudent judgement.

### Audit

The LDA Act provides that the Auditor to be appointed shall be the Director of Audit. This ensures the independency of the system. Every year the National Audit Office sends officers to carry out Audit and Financial Statement of the LDA and to report thereon. All weaknesses and their findings are reported to Management through a Report. The External Auditor's Report is reviewed and presented in management meetings. The External Auditor's Report is presented to the Board.

### Principle EIGHT-RELATIONS WITH SHAREHOLDERS AND OTHER KEY STAKEHOLDERS

The Board shall meet as often as is necessary but at least once every month at such a time and such a place as the Chairperson may determine.

At any meeting of the Board, 9 members shall constitute a guorum.

In the absence of the chairperson at a meeting of the Board, the members present shall elect another member to act as Chairperson of the meeting.

Where a member has an interest, direct or indirect, in a matter before the Board ,he shall, as soon as reasonably practicable, disclose to the Board the nature of his interest and shall not take part in the deliberations of the Board relating to that matter.

#### **Observation/Remarks:**

#### 1. Cut off Drain

No proper channeling of stormwater runoff into the cut off drain, in turn converging towards the residential area.

- The 'Cut Off Drain' being covered did not allow proper ingress of stormwater runoff from the upstream catchment.
- All metal gratings along the cut off drain have been completely block/silted.

#### 2. Near Fatima Hall

- Inlet and Metal gratings completely silted/obstructed with rocks, soil and debris.
- No proper measures of channeling stormwater from the 2 natural drainage paths into drain and as such recurrent blocking/obstruction will be observed even if maintenance is performed regularly.

# Status of the National Flood Management Programme for the financial year 2022/2023

The National Flood Management Programme (NFMP) comprised 1,721 drain projects as at end June 2023. These have been planned to be implemented over a period of five years.

During the Financial Year 2021/22, 865 projects have been kick started and same are in progress for the current financial year. During the Financial Year 2022/23, Rs 3.8 billion were earmarked for the implementation of projects under the National Flood Management Programme.

The financial provision of Rs 11.7 billion was expected to disbursed as follows:

- Rs 3.6 billion for the financial year 2021/2022;
- Rs 4.2 billion for the financial year 2022/2023 which was revised to Rs 3.8 billion in budget speech 2022/23;
- Rs 3.9 billion for the financial year 2023/2024 which was revised to Rs 3 billion in budget speech 2023/24;



# LAND AND DRAINAGE MASTERPLAN

The Land Drainage Masterplan (LDMP) was initiated in January 2020 and spearheaded by the Land Drainage Authority. The main objective of the study is to reduce the vulnerability of the population to heavy rainfall and flood events in the context of climate change.

The project is also aligned with the overarching aim of building climate resilience of the country. The AFD is engaged with the Republic of Mauritius (ROM) to support the implementation of its Nationally Determined Contribution (NDC), with a particular focus on climate change adaptation. To this effect, AFD and the ROM signed a memorandum of understanding on the 12th of December 2017, during the One Planet Summit, organised by the French Presidency, which sets the respective engagements under the Adapt'action initiative.

The Master Plan includes the following key deliverables:

- An inventory and mapping of existing natural and manmade drainage infrastructures including
- Natural Drainage paths, Environmentally Sensitive Areas (Wetlands), and lowlands;
- An identification of flood-prone areas, including the impact of future developments;
- The definition of a reference hydrology at the scale of each rainfall sub-catchment, based on new IDF curves,
- The elaboration of flood mapping and associated vulnerability assessment;
- The proposal for national rules in order to account for land drainage issues in territorial development with the objective of flood risk reduction, taking into account water quality and biodiversity preservation to improve the resilience of the country in the context of climate change.
- The definition of broad protection objectives in terms of structural measures to be implemented in flood risk zones at the scale of the most vulnerable catchments, based on detailed studies conducted at a more localised level; 140
- A 10-year action plan for implementation on the short, medium and long term;
- New Design Guidelines for Engineers/Planners and modelling output for vulnerable sites;
- Proposal for an enhanced Land Use Planning introducing No Go Zones and No Expansion
- Zones in flood risk areas (have been removed following Cabinet Decision dated 01 July 2022)
- In addition, thereto, the Land Drainage Masterplan comprises of the following:
- Risk evaluation for the next five years
- State of preparedness: critical analysis of the institutional safeguards and infrastructural defences.
- Measures to be taken and
- Early warning system and rapid response mechanism for drainage and evacuation141 Meetings and presentations held upon completion of the Land Drainage Masterplan.








### December 2022

# Training of Head Planners in connection to processing of Building and Land Use Permits (BLUPs)

In the context of the Land Drainage Masterplan (LDMP), the Flood Prone Map and Natural drainage path have been derived. This planning tool has been transmitted to the Local Authorities to be considered while processing the Building and Land Use Permits (BLUPs). This is geared towards building resilience to flooding and to specific conditions that may be prescribed to attenuate any risk of inundation and for future construction.

So far, four (4) trainings by the LDA have already been imparted to Planners of the Local Authorities. In view to further train the Head Planners on the new GIS Platform, the Land Drainage Board, upon request of the Local Authorities, approved that a short professional course on GIS be organised accordingly. Therefore, the University of Mauritius has been approached in line with the Memorandum of Understanding between the LDA and UOM. The training was scheduled as follows:

- Tuesday 25 October 2022;
- Thursday 27 October 2022;
- Saturday 29 October 2022;
- Monday 31 October 2022;
- Thursday 03 November 2022

The short professional course on GIS is aimed at providing training to those working in landuse planning. The objective is to support officers for the use of the Flood Map from the Land Drainage Authority. At the end of this training, the head planners will be certified to be user friendly with the GIS Software. The participants will be able to:

- 1. Locate a site on the Flood Map of the LDA
- 2. Create shape files and buffers
- 3. Create Maps



# NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2023

# 1 General information on reporting entity

The Land Drainage Authority (LDA), a body corporate which operates under the aegis of the Ministry of National Infrastructure and Community Development (NDU), was established on January 2018 and is regulated by the Land Drainage AUTHORITY Act No 1 of 2017 proclaimed on 1 June 2018. The Authority principal place of business is Medine Mews, Level 11, La Chaussee Street, Port Louis.

# Principal activity

The Land Drainage Authority is responsible for the development and implementation of the Land Drainage Master Plan and coordinating the construction, upgrading and maintenance of drainage infrastructure.

# 2 Statement of Compliance and basis of preparation of financial statement

### (a) Statement of compliance

The financial statements have been prepared in accordance with International Public Sector Accounting Standards (IPSAS) issued by the International Public Sector Accounting Standard Board (IPSASB) which is a Board of International Federation of Accountant Committee (IFAC). The Land Drainage Authority has adopted IPSAS in the preparation of its financial statements in compliance with Statutory Bodies (Accounts and Audit) Act as amended in 2010.

The financial statements have been prepared on an accrual and going concern basis and the accounting policies have been applied consistently throughout the year.

# (c) Reporting date

The financial statements have been prepared for the year ended 30 June 2023.

# (d) IPSAS issued but not yet effective

The financial statements comply in all material aspects with applicable IPSAS.

The following Standards had already been issued but not effective:

These standards will have no material impact on the financial statements.

# (e) Functional and Presentation of Currency

The functional and presentation currency of the Financial Statements is Mauritian Rupees (MUR), rounded to the nearest rupee.

# 3 Significant accounting policies

# (a) Plant and Equipment

All plant and equipment are stated at historical cost less accumulated depreciation. Historical Cost comprises of all costs attributable to bringing the assets to working condition for its intended use. Depreciation is provided at rates calculated to write off the cost of fixed assets over their estimated useful life on a straight-line basis. A full year depreciation is charged on acquisitions/additions during the year.

The principal rates used are:

Plant & equipment :20%

Computer :20%

Furniture and fittings :20%

Motor vehicle :12.5%

Intangible Assets :12.5%

# **Capitalisation Policy**

Property, Plant and equipment valued at Rs 3,000 and above are capitalized and treated as fixed assets. Assets less than Rs 3,000 per item are expensed to the Statement of Financial Performance in the year which they are incurred.

# (b) Intangible Assets

Intangible assets are stated at historical cost less accumulated amortisation. Historical Cost comprises of all costs directly attributable to bringing the assets to working condition for its intended use.

Amortisation is charged so as to write off the cost of intangible asset over its expected useful life using the straight line method. A full year amortisation is charged on acquisitions/additions during the year. The annual amortisation rate used for this purpose are as follows:

Intangible Assets :12.5%
Digital Elevation Model (DEM) :10%

# (c) Provisions and Contingent Liabilities

A provision is recognized when the Authority has a present obligation as a result of a past event; when it is probable that an outflow of resources embodying economic benefits or service potential will be required to settle the obligation; and when a reliable estimate can be made of the amount of the obligation.

# (d) Expense Recognition

All expenses are accounted for in the Statements of Financial Performance on the accrual basis.

# 3 Significant accounting policies (Cont'd)

# (e) Revenue Recognition

Revenue is recognised in accordance with IPSAS 23 where revenue has been classified as revenue from non-exchange transactions.

# IPSAS 23 Revenue from Non-Exchange Transactions

The objective of IPSAS 23 is to prescribe requirements for the financial reporting of revenue arising from non-exchange transactions, other than non-exchange transactions that give rise to an entity combination. This standard deals with issues that need to be considered in recognising and measuring revenue from non-exchange transactions, including the identification of contributions from owners. Grants are recognized as revenue to the extent that the entity has satisfied the conditions attaching to the grant.

### (f) Comparative Information

Comparative information has been restated or reclassified, as necessary, to conform to Current years presentation. The comparative information covered the period 1 July 2021 to 30 June 2022 while the current financial statements covered the period 1 July 2022 to 30 June 2023.

# (g) Budget Information

The original budget for financial year 2022-2023 was approved at the 3rd reading of the Appropriation Bill on 29 June 2022.

The Authority's budget is prepared on a different basis from the financial statements. The financial statements are prepared on accrual basis using a classification based on the nature of expenses in the statement of financial performance, whereas the budget is prepared on a cash basis. The amounts in the financial statements were recast from the accrual basis to the cash basis and reclassified by presentation to be on the same basis as the approved budget. A comparison of budget and actual amounts, prepared on the above basis to the approved budget, is then presented in the comparison of budget and actual amounts.

# (h) Use of Estimates & Judgement

The preparation of financial statements in conformity with IPSAS requires the use of certain critical accounting estimates. It also requires the Board to exercise its judgement in the process of applying the Authority's accounting policies. Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances. For the year ended 30 June 2023, there were no areas involving a higher degree of judgement, or complexity or areas where assumptions and estimates are significant to the financial statements.

# 4 Risk management policies

A description of the various risks to which the Authority is exposed is shown below as well as the approach taken by management to control and mitigate those risks.

# (i) Financial Risk

The Authority is not much exposed to financial risks. The Authority does not use any derivative financial instruments to hedge risk exposures. The Authority is not exposed to currency risk, interest rate risk and credit risk.

# (ii) Operational Risk

Operational risk, which is inherent in all organisations activities, is the risk of financial loss instability arising from failures in internal controls, operational processes or the system that supports them. It is recognized that such risks can never be entirely eliminated and the costs of controls in minimizing these risks may outweigh the potential benefits.

# (iii) Legal Risk

Legal risk is the risk that business activities of the Authority have unintended or unexpected legal consequences. The Board identifies and manages legal risks through legal advice.
